### **Recall Description**

On certain pickup trucks equipped with manual transmissions, the parking brake friction linings may wear to an extent where the parking brake can become ineffective in immobilizing a parked vehicle.

#### Remedy

Dealers will install a low-force spring clip retainer for vehicles equipped with a PBR parking brake system free of charge. On vehicles equipped with the TRW parking brake system, dealers will install a redesigned parking brake cable assembly free of charge.

#### **Recall Description**

Certain pickup trucks have galvanized-braided-steel tailgate support cables used to support the tailgate in the full open (horizontal) position. Over time these cables can corrode and fracture when loads are applied to them.

#### Remedy

Dealers will replace the galvanized support cables with stainless steel support cables. In addition, dealers are to inspect the tailgate hinge and replace it, if necessary free of charge.
