Recall Description

The front fuel tank strap frame T-Slot bracket on the above-mentioned vehicles may corrode permitting the front fuel tank strap to detach. With the front fuel tank strap detached, the rear strap primarily secures the fuel tank, however, the front of the fuel tank may be allowed to lower several inches.

Remedy

FCA US will conduct a voluntary safety recall to install a fuel tank strap reinforcement bracket on all of the involved vehicles. If the fuel tank strap is found to be disconnected from the original frame bracket, the front and rear fuel tanks straps as well as the locking nuts, will be replaced.
