Recall Description

General Motors has decided that a defect which relates to motor vehicle safety exists in 2004 - 2008 model year Chevrolet Optra vehicles. Heat generated within the headlamp switch or daytime running lamp (DRL) module, which are both located on or near the left side of the steering column, could melt the headlamp switch or DRL module and cause a fire which may result in personal injury and/or property damage.

Remedy

General Motors will provide its plan for remedying the defect as soon as it is confirmed.
