Recall #: N140260 | AUXILIARY BATTERY Recall Date: 2014 Jul 02

Recall Description

General Motors has decided that a defect which relates to motor vehicle safety may exist in certain 2007-2011 model year Chevrolet Silverado and GMC Sierra 2500/3500 series vehicles equipped with an auxiliary battery (TP2). The owner manual for these vehicles does not specify a maximum amperage rating for the auxiliary battery feed to a trailer harness. The auxiliary battery feed is equipped with a fusible link, designed to melt and open-circuit if an electrical overload occurs, in order to prevent damage or a possible fire in the vehicle wiring harness.

Remedy

Dealers are to install a jumper harness with a 40A inline fuse. In addition, dealers are to provide customers with a copy of the Owner Manual supplement. The supplement includes the maximum amperage rating for the auxiliary battery trailer feed with the 40 ampere inline fuse installed.

Recall #: N150817 | SPI Air Bag Inflator Recall Date: 2015 May 28

Recall Description

Inflators subject to Takata equipment recall 15E-041 were installed in certain 2007-2008 model year Chevrolet Silverado and GMC Sierra 2500/3500 Heavy Duty pickup trucks as original equipment. In accordance with Takata's defect determination for these Takata inflators, GM is recalling these vehicles to replace these Takata inflators. The propellant wafers in some of the subject inflators may experience an alteration over time, which could potentially lead to over-aggressive combustion in the event of an air bag deployment. Depending on the circumstances, this potential condition could create excessive internal pressure when the air bag is deployed, which could result in the body of the inflator rupturing upon deployment.

Remedy

Dealers will replace the front passenger air bag inflator, free of charge.

Recall Description

General Motors has decided that a defect, which relates to motor vehicle safety, exists in certain 2007-2009 model year Chevrolet Silverado and GMC Sierra vehicles. Some of these vehicles may have a condition where the sensing and diagnostic module (SDM), located beneath the driver's seat, may corrode due to a significant quantity of snow and/or water containing road salt or other contaminants entering the vehicle and saturating the acoustical padding beneath the carpet. The SDM is located under the driver's seat underneath the acoustical padding.

Remedy

Dealers are to remove the acoustical pad above the SDM, inspect the SDM, and replace the SDM, if necessary.
