### NOW THEREFORE THE PARTIES AGREE:

**TERM:** This Agreement shall commence on the Effective Date and shall be for a term of 5 years ("Initial Period"), and shall continue thereafter for successive one year periods ("Renewal Period") unless and until terminated by either party at the end of the Initial Period or at the end of the then current Renewal Period, on ninety (90) days prior written notice to the other party, unless otherwise terminated as elsewhere provided in this Agreement.

**EQUIPMENT RENTAL:** CanGas agrees to install and lease to Customer, and Customer agrees to receive and lease from CanGas, the Equipment. Customer agrees to pay CanGas an Equipment rental charge ("Rental Charge") of \$ 120 per annum plus all applicable taxes, payable annually in advance. CanGas reserves the right to change the Rental Charge from time to time throughout the Initial Period or any Renewal Period of this Agreement.

**PRODUCT PRICING:** CanGas agrees to sell and deliver to Customer and Customer agrees to purchase and receive from CanGas, all Customer's Propane requirements throughout the term of this Agreement, at the then current prices for Propane of CanGas in effect at the time and in the place of each delivery to Customer, plus all applicable taxes.

### Additional Provisions:

THE PARTIES EXPRESSLY AGREE TO THE ABOVE TERMS AND CONDITIONS AND THOSE ON THE REVERSE SIDE HEREOF.
