#### **Recall Description**

General Motors has decided that a defect which relates to motor vehicle safety exists in certain 2020 - 2024 model year Chevrolet Silverado Heavy Duty (2500/3500 series) and GMC Sierra Heavy Duty (2500/3500 series) vehicles in the US and Canada and certain 2020 - 2023 model year Chevrolet Silverado 1500 series and GMC Sierra 1500 series vehicles in Canada. Vehicles equipped with power-unlatching tailgates, under certain conditions, may allow water to intrude into these vehicles' tailgates and come into contact with the electronic gate-release switch, potentially causing a short circuit. The gate may inadvertently unlatch while the vehicle is in Park.

#### Remedy

Dealers will replace the exterior touchpad switch assemblies.
