Recall Description

SOFTWARE PROGRAMMING IN THE HVAC CONTROLLER ALLOWS A COMBINATION OF NUMEROUS DATA INPUTS TO TEMPORARILY OVERLOAD THE CALCULATION CAPACITY OF THE CONTROLLER, RESULTING IN INCORRECT SIGNALS TO BE TRANSMITTED TO THE HEATER CASE MODE DOOR. THIS CAUSES THE MODE DOOR TO MOVE TO UNSELECTED POSITIONS DURING HEATER OPERATION UNTIL THE CONTROLLER RECOVERS AND RETURNS TO PROPER OPERATION. OVER TIME, THIS EXCESSIVE MOVEMENT MAY DAMAGE THE MODE DOOR SHAFT.

Remedy

THE DEALERSHIP WILL REPLACE THE HEATER CONTROLLER ON YOUR VEHICLE AND INSPECT THE HEATER CASE MODE DOOR SHAFT FOR DAMAGE. IF NECESSARY, THE DEALER WILL REPAIR THE MODE DOOR SHAFT. THESE SERVICES WILL BE PROVIDED FREE OF CHARGE. T
