Recall Description

General Motors has decided that a defect which relates to motor vehicle safety exists in certain 2005 2009 model year Buick LaCrosse

vehicles; certain 2006 2008 Saab 9-7X and Isuzu Ascender vehicles; certain 2006 2007 Buick Rainier, Chevrolet Trailblazer and GMC Envoy vehicles; certain 2007 Pontiac Grand Prix vehicles; and certain 2006 Chevrolet Trailblazer EXT and GMC Envoy XL vehicles. The headlamp driver module (HDM) in certain of these vehicles may not operate properly in the thermal environment of the underhood electrical center. If the HDM is not operating correctly, the low-beam headlamps and daytime running lamps could fail to illuminate. This failure could be intermittent or permanent. This condition does not affect the high-beam headlamps, marker lamps, turn signals, or fog lamps.

Remedy

Dealers are to replace the headlamp relay (HDM) that resides in the under hood bussed electrical center (UBEC) free of charge.
