Recall Description

THE FRONT AXLE TUBE WELDS MAY NOT HAVE BEEN WELDED CORRECTLY DURING THE MANUFACTURING PROCESS. IMPROPERLY WELDED FRONT AXLE TUBES COULD ALLOW THE DIFFERENTIAL HOUSING TO ROTATE UNDER HIGH TORQUE OPERATING CONDITIONS WHILE IN FOUR WHEEL DRIVE. SHOULD THE FRONT AXLE TUBE WELDS BREAK, THE DIFFERENTIAL COULD ROTATE AND CAUSE THE FRONT PROPELLER SHAFT UNIVERSAL JOINT TO BREAK. .

Remedy

FOR VEHICLES EQUIPPED WITH AN AUTOMATIC TRANSMISSION, THE FRONT AXLE MUST BE INSPECTED. FRONT AXLES THAT HAVE BROKEN WELDS WILL HAVE A NEW FRONT AXLE ASSEMBLY INSTALLED. FRONT AXLES THAT ARE NOT DAMAGED WILL HAVE REINFORCEMENT BRACKETS INSTALLED. FOR VEHICLES EQUIPPED WITH A MANUAL TRANSMISSION, THE FRONT AXLE MUST BE REPLACED.

Recall Description

THE DIESEL FUEL HEATER ELECTRICAL CONNECTOR MAY OVERHEAT AND CAUSE A FUEL LEAK. THE DIESEL FUEL HEATER HOUSING AT THE FUEL HEATER ELECTRICAL CONNECTOR MAY OVERHEAT, LEADING TO THE FAILURE OF THE O-RINGS THAT SEAL THE MALE ELECTRICAL TERMINALS IN THE DIESEL FUEL FILTER/HEATER ASSEMBLY.

Remedy

THE DIESEL FUEL HEATER WIRE HARNESS ELECTRICAL CONNECTOR MUST BE REPLACED ON ALL VEHICLES. ALSO, THE DIESEL FUEL FILTER/HEATER HOUSING MUST BE INSPECTED FOR FUEL LEAKS. IF A FUEL LEAK IS FOUND, THE DIESEL FUEL FILTER/HEATER ASSEMBLY MUST BE REPLACED.

Recall Description

The Brake Transmission Shift Interlock (BTSI) locking pin may become stuck in the open position. A BTSI locking pin stuck in the open position may allow the transmission to be shifted out of PARK and to or from any gear position without depression of the brake pedal and/or without the key in the ignition, if a key is applicable.

Remedy

For 2013-2017 model year; Inspect the Brake Transmission Shift Interlock (BTSI) operation and replace if necessary. The Body Control Module (BCM) software will also be updated. For 2009-2012 model year; replace the BTSI, BCM software update not applicable.

Recall Description

Torque specification information included in vehicle Service and Owner's Manuals may cause flanged lug nuts to be torqued to a level that may cause the wheel stud to yield and eventually break during vehicle operation.

Remedy

FCA US will conduct a voluntary safety recall on all affected vehicles. For vehicles in Y26 and Y60, FCA US will inspect the wheel studs and update the torque specification in owner's information and published service documents. Vehicles found with studs that are potentially yielded will have a new stud installed and the lug nuts tightened to the updated torque specification. For vehicles in Y36, FCA US will update the torque specification in owner's information and published service documents
